2. Motion was made by Mayor Ellis and second by Council member Mendoza to approve Resolution R-817-1124 authorizing the City Manager as the city's representative in matters pertaining to the city's participation in the Texas Community Development Block Grant Program. Motion carried.
3. Motion was made by Mayor Ellis and second by Council member Alarcon to approve Resolution R-816-1124 authorizing the submission of a Texas Community Development Block Grant Program Application. This commits \$75,000 in matching funds toward the application's activities. Motion carried.
4. Motion was made by Mayor Pro-Tem Parker and second by Council member Atchley to award the sale of city property WD&FW JOHNSON SECTION 53, BLOCK Y, ACRES 1.61 NORTH 214 to Julio Ortega for \$12,500. Motion carried.
5. Motion was made by Mayor Pro-Tem Parker and second by Mayor Ellis to adopt the Covered Applications and Prohibited Technology Policy required by S.B 1893 for cities to adopt a policy: (1) prohibiting the installation of TikTok or another covered application on any owned or leased devices by the government entity; and (2) requiring the removal of covered applications from those devices. Motion carried.
